RWE launches its endowment fund to support local initiatives in France

- The RWE endowment fund will provide up to €2,000 annually per MW installed for each Group's operational asset in France.
- Local associations can submit a community-based project of general interest to apply for funding.
- This program will be granted throughout the whole lifespan of the wind or solar farm.

Essen, September 25th 2024

RWE is launching a endowment fund to support local initiatives across France. With this program, RWE aims to strengthen the connection between renewable energy production and local communities. By the end of 2024, the fund will be deployed in every French region where RWE operates wind or solar farms. The concept is straightforward: RWE's operational assets will contribute up to €2,000 per megawatt (MW) per year. This locally focused fund will support community projects through a call for proposals, allowing local associations to submit projects that reflect their community's needs and aspirations. The goal is to ensure the value created by renewable energy benefits the regions that host these projects.

Joseph Fonio, Chairman at RWE Renouvelables France : « With this endowment fund, RWE is actively committed to sharing value with the communities that host our projects. By providing financial support to local initiatives that promote the ecological transition, the fund serves two important goals: delivering tangible benefits to local residents and amplifying our efforts toward a greener future.»

Supporting projects to promote local development in France

In practice, RWE will finance its fund based on the capacity of its solar and wind farms, and will launch regional calls for proposals. Local associations can submit projects focused on ecological transition, such as enhancing local heritage (e.g., renovations, educational trails), preserving biodiversity (e.g., awareness campaigns, installing birdhouses), or promoting energy transition (e.g., energy-saving initiatives). Each year, regional committees made up of RWE employees and external experts will select the winning projects.
